Economic Development: D. Goldberg

- OCD continues sharing information with businesses and working to assist them now that Philadelphia has entered a modified green phase of reopening.
- Many restaurants have begun to take advantage of cafe seating and streetery options.
 Staff is helping them with applications and regulations.
